1. DIRECTOR'S REPORT

Interim Director Margaret Wallace Brown provided brief remarks encouraging the BAC's work toward improving bicycling in Houston. The Director's Report was given by Assistant Director Jennifer Ostlind.

2. CHAIR'S REPORT

Chair Maya Ford provided the Chair's Report. Chair Ford emphasized safety as the paradigm shift in building bikeway infrastructure.

5. SAFER STREETS INITIATIVE UPDATE

This item was skipped due to the absence of Houston Public Works representative Ian Hlavacek.

6. BUILD 50 CHALLENGE UPDATE

Staff member Pete Eccles presented an overview of the Build 50 Challenge, the regional spine network plan, and the status of bikeway implementation. All projects in Near Northside (Lyons, Hardy/Elysian, Downtown Connector and Kelley Street), are designed and entering construction. Lyons Avenue construction is complete. Engagement and information distribution regarding the use of the bike lanes is still ongoing.

The Third Ward package of bikeways are 100% designed but have not been constructed. These include the Austin corridor, Gray, Polk, Cullen, Hutchins and Cleburne.

Eccles also outlined the total mileage of bikeways that have been implemented towards the Build 50 Challenge. Houston Parks Board built 24.8 miles, METRO 1.1 miles, Westchase Management District 0.3 miles, TIRZ 5 0.5 miles, and other Precinct 1 projects total 7.6 miles. 9.6 miles are under construction and 8.0 miles have been let for construction by Precinct 1. The total mileage towards the Build 50 Challenge is 51.9 miles.

City of Houston CIP-funded projects (Acres Home network, Patterson, 11th Street, North Main and Quitman) are still in concept or early design stages, so they will not count towards the Build 50 Challenge.

Lastly, Eccles outlined upcoming meetings and engagement opportunities for bikeway projects still in the design phase. He also posed the question of what a future bikeways challenge might look like. Discussion ensued.

7. VISION ZERO

Staff member Lauren Grove presented a draft resolution for the BAC. The BAC resolution will be presented to the Planning Commission May 9. The language in the BAC resolution will serve as the starting point for the Executive Order for Mayor Turner. Discussion ensued. Staff committed to revise the draft BAC resolution with more holistic language and send the final draft for review by the Members via email.
