

#### The Lisa Torry Smith Act

The act was established to elevate awareness and increase public safety after Lisa Torry Smith was killed by a driver in a crosswalk. The following is a brief timeline of events:

**October 2017** – Lisa Torry Smith was struck by a car and killed while walking her 6-year-old son to school.

**November 2019** – The investigation revealed that the driver was turning left into the intersection when the driver collided with the two pedestrians. The driver was charged with criminally negligent homicide, but the grand jury did not indict the defendant.

**December 2020** – Initial legislation was drafted and sponsored by State Rep. Ron Reynolds and State Sen. Joan Huffman. The act is designed to prevent pedestrian deaths by requiring drivers to stop and yield to pedestrians before they travel through intersections and crosswalks.

May 2021 – The Lisa Torry Smith Act was signed into law.

#### **Frequently Asked Questions**



#### What should I do if I see this sign?

If you encounter this sign while driving you should stop and yield the right of way to pedestrians and bikers lawfully in the intersection or an adjacent crosswalk.

#### What will happen if I hit someone in the crosswalk?

A person commits criminal negligence if they operate a motor vehicle within the area of a crosswalk; and causes bodily injury to a pedestrian or a person operating a bicycle, motor-assisted scooter, electronic personal assistive mobility device, neighborhood electric vehicle, or golf cart. The Texas Transportation Code Section 545.428 states that the offense is a Class A misdemeanor if the offense results in bodily injury and a state jail felony if the offense results in serious bodily injury.

#### What can I do to prevent pedestrian deaths?

- Follow the rules of the road and obey signs and signals
- Watch for pedestrians while entering or exiting driveways or backing up in parking lots
- At intersections drivers should look for people walking, biking, and driving in all directions
- Avoid alcohol and drugs when traveling
- · Always stay alert
- Walk on sidewalks whenever possible, or far away from traffic if there are no sidewalks

Traffic safety legislation like the Lisa Torry Smith Act aligns with the Vision Zero Houston goal to end traffic deaths and serious injuries on Houston streets by 2030. Visit **visionzerohouston.com** for more information.
