As opposed to sending it to all 20 on the proposed list, staff will start with Silver Eagle because they may help us formalize the questions in the right words and then maybe expand that to the next tier.
    - Staff will reach out to other cities, that may have gone through the training issues, and see what has worked or what has not worked for them.
    - Staff will contact Silver Eagle and report back to the subcommittee at the March 2023 meeting.
